## NOTICE OF RACE

### A Davis Island Yacht Club Boat of the Year Event

#### 1 RULES

The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.

#### 2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to any and all boats, with WFPHRF measurement certificates, plus J-24s and Melges-24s.
- 2.2 PHRF boats may enter into one of the following divisions: Spinnaker A, Spinnaker B, non-Spinnaker and Racer/Cruiser.
- 2.3 Boats may enter by using one of the following methods:
  - (a) Complete the online form on the DIYC website – diyc.org
  - (b) Complete the attached form and send it, together with the required fee, to the address on the form.
  - (c) Deliver an entry form and fee to the registration desk by 0930 on January 16.

*Please note that late fees apply for entries received after January 9.*

#### 5 SAILING INSTRUCTIONS

The sailing instructions will be available at registration and may also be available on the Davis Island Yacht Club web site (diyc.org) prior to the event.

#### 6 THE COURSES

- 6.1 One distance race is planned for Racer Cruisers and may be up to 20 nm, weather permitting.
- 6.2 All other classes will sail windward/leeward courses around drop marks. Three races are planned. One race is required to be completed to constitute a regatta.

#### 7 PENALTY SYSTEM

For all divisions except Melges 24 the Scoring Penalty, rule 44.3, will apply. For the Melges 24 class rules 44.1 and 44.2 are changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

#### 8 SCORING

A boat's score will be the total of her race scores.

#### 9 RADIO COMMUNICATION

- 9.1 Boats shall have a VHF radio capable of receiving transmissions on channel 68.
- 9.2 Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction applies to mobile telephones.

#### 10 PRIZES

- 10.1 Prizes will be awarded at dinner on January 16.
- 10.2 The Clint Johnson Memorial Trophy will be awarded to the overall winner from the following divisions: Spinnaker A, Spinnaker B, non-Spinnaker, Racer/cruiser. All divisions will receive prizes based on the entries in each division:

I understand that serious accidents occasionally occur during sailboat racing, and that participants in sailboat racing occasionally sustain mortal or serious personal injuries and/or property damage as a consequence, and I knowingly assume all of the risks of sailboat racing. I agree that this waiver is binding on my heirs, representatives, successors and assigns.
